These orders will be applicable to the non-executives subject to following conditions:

- No Vigilance case is pending and no punishment is current against the official.
- All the concessions given by BSNL to non-executives in relation to OTBP/BCR/GF IV/ACP etc after 01.10.2000 stand withdrawn with immediate effect. However, the cases settled prior to the issue of BSNL CO. New Delhi order dated 23.03.2010 need not to be reopened unless the employee himself opts for NEPP.
- The pay Scale upgradation will mean placement from present IDA non-executive pay scale to the next higher non-executive IDA pay scales. The pay upgradation will be notional if the date of upgradation is before 01.04.2008. The actual benefits of pay fixation will be paid only from 01.04.2008.
