Please refer to our earlier communications in respect of the TDE Rajgarh at Biora, Shri N.P. Singh, some glaring facts are brought to our notice which indicates to apprehend that the BSNL revenue has been converted in to personal revenue by him.

It is reported to us that Shri N.P.Singh has purchased Agricultural land on his personal name & on the name of his wife Smt. Usha Singh jointly in Village Jhagaria Khurd, Khasra No. 289, PHN.24, Vikas Khand, Fanda, Tah-Hujur, Distt.Bhopal. The sale deed for the purchase of the land amounting to Rs.10,40,000 has been executed on 20-04-2010. The total area of the land is 2.325 acre.

Similarly, Shri N.P.Singh, TDE Biora has purchased another land on his name and on the name of his wife Smt.Usha Singh jointly in Village Jhagaria Khurd, Khasra No. 290, PHN.24, Vikas Khand, Fanda, Tah-Hujur, Distt.Bhopal. The sale deed for the purchase of land amounting to Rs.13,40,000 has also been executed on the same day i.e.20-04-2010. The total area of the land is 3.000 acre. Both the lands are purchased from Shri Harinarayan Sahu S/o Shri Mohan Lal Sahu, resident of Village Barraai, Block Fand, Post Bagroda, Tah. Hujur Distt. Bhopal. The amount of Rs.23,80,000 has been paid by cheque.

Since, Shri N.P.Singh, is reported to, has worked for quite some time in vigilance section of the Circle Office Bhopal, hence he might have obtained permission for purchase of land from the competent authority and might have also disclosed the source of income where he has earned/received money from. But, nevertheless the money involved for purchase of land including stamp duty charged is huge, therefore the apprehensions as if the money of the BSNL has been converted in to personal money in big way is natural one.
