- That they will have no claim for repatriation to the parent SSA.
- That on their transfer to new SSA, they will be eligible for confirmation only according to their position in the gradation list of that SSA.

- The declaration on the above points is obtained and pasted in Service Book and PF.
- No dues are outstanding against the official.
- No vigilance/disciplinary case is pending/ contemplated against the official.
- Official is not undergoing any punishment.
- EI/HPL and other leave cases may be settled before struck off.
